Prior to issuance of grading/excavating permit, an inspection <u>must</u> be completed by the storm water management program to insure compliance with §12-3040) of the storm water management ordinance. The following information must be attached with this application when submitted for approval:

Site Map indicating location of intended work area being submitted for grading approval.
Three sets of Plans showing all specifics of the grading/excavation, including location, size, materials, etc., and supporting data consisting of a soil engineering report and engineering geology report. The plans and specifications shall be prepared and signed by a civil engineer and must comply with \$12-305 of the Smyrna Municipal Code.

NOTE: Once this form has been approved by the Public Works Department, an email will be sent indicating fee amount due and the pre-construction meeting time.

Once pre-construction meeting is completed, the Grading Permit will be issued by the Public Works Department (615) 459-9766. License information may be submitted prior to the pre-construction meeting. The following information is required to be submitted to obtain the Grading Permit:

- 1. Tennessee Contractors License.
- 2. Workman's Compensation Insurance Certificate.
- 3. Town of Smyrna Business License For Information Call Treasury at (615) 459-2553.
- 4. Payment for correct fee due. (Please do not pre-mail payment, instead bring to the pre-construction meeting.)
